I am very pleased to inform you have been selected to play in the 7<sup>th</sup> Annual “Future Stars” Kentucky vs. Tennessee Future Stars Classic. The game will be played Saturday, June 18<sup>th</sup> in Bowling Green, KY @ Western Kentucky University at L.T. Smith Stadium (game day, ticket, and banquet info will be announced on the website in the coming weeks) ...

You will be asked to report to camp in Knoxville, TN on Wednesday June 15<sup>th</sup> (9am Eastern) – specific time and check-in info will be posted later this month on website. You will be expected at ALL times to remain in camp and attend all practices, meetings, and any other team events. If there is a family emergency that forces you to leave camp that is understandable; having to attend a baseball or basketball game does NOT fall in the “emergency” category. Get that worked out before you attend!

There is a team fee (detailed information found on separate attachment). Players depart with their families AFTER the game. If you are in the first game of day please stay around and support “Team Tennessee” in the 2<sup>nd</sup> game.

Players are responsible for their own equipment (helmet, mouthpiece, shoulder pads, pant pads (or girdle), practice pants, belt, cleats) we will provide Practice Jersey, Game Jersey & Game Pants (on a different attachment you will get a list of EVERYTHING you will need). Our game pants are slotted so please don't bring “snap” in pant pads. We recommend you wear a girdle.

Players and families will have the option to buy a few “extras” (be sure to check Optional Items attachment). Parents, family, etc. can purchase Tennessee Future Stars gameday t-shirts with team roster printed on the back of shirt, you can wear on gameday to show your support for the Team Tennessee. These items MUST be pre-ordered! These items are NOT mandatory to purchase.

Lastly, if money is an issue then get out and do some individual fundraisers. Possibly your coach, family, church, school, booster club, local business can help you raise the needed funds. In past we've had players get “sponsors” (by the people mentioned above), this event is a big deal (your selection) so people are always willing to help! If you decide NOT to attend please inform us **immediately** so we can give your roster spot to an alternate.

- **Wednesday, June 1<sup>st</sup>** - Remaining Team Fee balance due.

We don't have extras on anything so be CAREFUL, what you list is what we order and what you wear, we order straight off your form. Ask coach to size at school if need be!



### Rules, Expectations & Housekeeping Notes

1. All players are expected to remain in camp at all times unless a family emergency occurs.
2. All players are expected to be on very best behavior at all times. You are representing your family, school, community, city & state. Don't let anyone down!
3. No guests will be permitted in athletes room.
4. Athletes **MUST** stay in their assigned rooms.
5. Do not bring any expensive items that can be lost or stolen. It is your own fault if that happens!
6. You will be expected to be **VERY** respectful to **ALL** coaches, directors, teammates, etc.
7. **NO** Fighting, **NO** Drugs, **NO** Weapons, **NO** Alcohol, **NO** Foul Language, **NO** Stealing Property that don't belong to you! **NO** bullying, **NO** making "fun" of anyone!
8. Wear your clothes the way there made to be worn; **NO** sagging.
- 9. If you damage and/or break anything you will be responsible for replacing!!**
10. Lights out means lights out! No walking around campus at night un-attended!
11. Nothing but your **VERY** best effort, behavior, etc will be accepted. If you loaf at practice you will **NOT** play!

**PLAYING TIME:** This year we have selected more players than any previous year. All players will receive playing time, not equal amounts, but everyone will play. Your gameday snaps are earned in practice, based on performance.

These coaches will do a great job in ensuring your son has a great **OVERALL** experience. Do **NOT** question the coaches judgment, this is an **ALL-STAR** game it is not treated the same way as a regular season game. You may or may not agree with everything your son's coach does, just be supportive regardless. Do **NOT** go to the coach and start questioning things, your son will be asked to leave camp immediately!! **NO** player will play the whole game, unless an injury to another player forces him too. Players only play **ONE** side of the ball!

**Skill guys, there is 1 football, NOT everyone will get equal touches, carries, passes thrown too, etc. The game is only a "small" piece of the overall Future Stars experience. So if Johnny plays less than desired plays don't count it as a bad experience. We select a big roster on purpose, so more kids can participate. We realize if we selected a smaller roster it would be easier to manage playing time but then \_\_\_ of kids wouldn't get the overall Future Stars experience!**

It is up to the coaches what positions the athletes play. Just because you play tailback on your school team that doesn't mean you will be tailback here. Again, just be supportive!! Certain positions require more/less depth so your son may have to play a new position this week, please be understanding if your son is asked to play a new position he never has played. You may be listed as \_\_\_ position on the list the coach **MAY** move you to a different position.

Anyone who can't handle the above rules, expectations, etc should think twice about attending. If a child breaks a rule it is highly possible we will immediately contact someone to come get him. Parents please remind the kids this before they attend. Players be on your best behavior, represent well and you will have a blast!!

## **FUTURE STARS “WHAT TO BRING” LIST**

**EQUIPMENT PACKING LIST:** Helmet (make sure all pieces are attached and tightened down, chin strap, screws, etc), Shoulder Pads (make sure all pieces are attached, all hooks, straps, etc), Girdle, Girdle Pads, Belt, Practice Pants (white preferred), Mouthpiece, Cleats. We recommend you bring an equipment bag, this helps you carry equipment to each practice and game day. Practice Clothing: make sure you bring plenty socks, under shirts, etc.

**GENERAL PACKING LIST:** Underwear, Socks, Toiletries (soap, shampoo, towels, toothbrush, toothpaste) for dorms; Pillow, Bedding (sleeping bag, sheets or blanket), Athletic Clothes: t-shirts & shorts, Athletic Shoes or slides, Swim wear (not guaranteed will get to swim but possible)

We recommend that you DO NOT bring electronics and/or expensive items that can be lost or stolen. Cell phones are okay (remember your charger). It is your decision if you bring an iPod, iPad, etc.
